has been briefed accordingly. The meeting has been scheduled with the department as
well to progress the conversation on the key issues that need to be dealt with around the
legislative amendments. The Minister has also undertaken to put the legislative
amendment issue on the program for next year, 2022.

6.2 Operational Update

BM conveyed the following update:

- Organisation largely operating remotely, but there is a skeleton staff that is available and that should be available to process whatever matters that are coming through;
- that the CSOS will be launching its Service Charter on Friday, 17 September, which is a pledge to CSOS stakeholders and community about what service they can expect from the CSOS;
- Appraise the members on the issue previously discussed of the transformation fund and that matter is progressing. The Minister has been briefed with regards to that and a letter



with a concept document has also been shared with her, and it is currently in the Minister's office. **BM** indicated that he hopes that their proposal with regards to the National Treasury retaining the funds for this purpose is going to carry the support that is needed and can then progress quite rapidly in terms of implementation. Procurement process underway to source assistance around a complete universe of schemes being identified and share some further details as that becomes even much clearer.
